Draft Galway City Development Plan 2023-2029

Notice is hereby given that Galway City Council, in accordance with Section 12 of the Planning and Development Act 2000 (as amended), has prepared a Draft Galway City Development Plan for the period 2023-2029 for the administrative area of Galway City.

The Draft Galway City Development Plan is accompanied by a Strategic Environmental Assessment (SEA) Environmental Report prepared in accordance with the Planning and Development Strategic Environmental Assessment (SEA) Directive (2001/42/EC) and the Planning and Development SEA Regulations 2004 (S.I. No. 436 of 2004) (as amended), and an Appropriate Assessment (AA) Natura Impact Report (NIR) pursuant to Article 6 of the Habitats Directive (92/43/EEC) and the Planning and Development Act 2000 (as amended). A Strategic Flood Risk Assessment (SFRA) also accompanies the Draft Plan.

The Draft Galway City Development Plan consists of the following:

- Volume 1: Written Statement
- Volume 2: Maps
- Volume 3: Environmental Assessments of the Plan, to include: the SEA Environmental Report, NIR and SFRA

All submissions /observations lodged within the above consultation period will be taken into consideration. Please note that late submissions /observations cannot be considered.

Public Information Drop-in Sessions are anticipated during the currency of the public consultation period Covid-19 restrictions permitting. Uimh. 436 de 2004) (arna leasú) ag gabháil le Dréachtphlean Forbartha Chathair na Gaillimhe, mar aon le Measúnacht Chúí (AA) Thuarascáil Tionchair Natura (NIR) de bhua Airteagal 6 den Treoir maidir le Gnáthóga (92/43/CEE) agus an Acht um Pleanáil agus Forbairt, 2000 (arna leasú).
